

Dear Tour Participants,

Thank you very much for your participation in the Pacific Gas and Electric Company tour of Diablo Canyon Power Plant (DCPP) on Wednesday, January 9, 2013. We believe this is a great opportunity for government officials and members of the public to meet plant leadership and to learn about plant operations, safety and security.

The tour is scheduled for January 9, 2013, following the conclusion of the Commission meeting, from approximately 1:00pm to 5:00pm, which includes travel time to and from PG&E's Energy Education Center. During the tour you will visit the turbine deck, control room, water intake and discharge structures, security building and the independent spent fuel storage installation (known as dry cask storage).

The attached documents contain important information about Diablo Canyon and the tour program. The first document is the Visitor Access Information Form (VAIF) needed for security clearance. **The VAIF must be completed in its entirety and submitted directly to:** John Lindsey, PG&E Communications Department. ## Important rules for ALL visitors:

- At least five business days before your visit, you must complete the “visitor access information form” in its entirety and forward to your host for security screening and badging. Please confine all visitor names to one form, if possible. Unfortunately we cannot accept any additions or substitutions after the form has been processed.
- Tour participants will be required to show a valid government-issued photo identification – US driver’s license, DMV issued ID, military identification, or passport are acceptable forms of identification.
- Required attire:
  - Long pants – no shorts, skirts or other attire that exposes legs or ankles.
  - Sturdy shoes, closed toed with leather uppers and heels less than 1 ½ inches tall – no tennis shoes, sandals, low-cut slip-on, or ballet style shoes.
  - Short-sleeved or long-sleeved shirt – no tank tops or sleeveless shirts.
  - At various locations, visitors may be required to wear hard hats, ear protection and safety glasses (provided).
- We also recommend a light jacket as some of the tour stops are outdoors.
- While at Diablo Canyon, you must comply with host instructions and public address announcements.
- Please note that no cameras or photography devices are to be used on-site without prior approval.

## If you are entering the Security Protected Area during your tour:

All visitors will go through a security search train to gain access to the protected area of the plant. The search train consists of a nitrate detector, metal detector and X-ray machine. A pat-down inspection may be required if security deems necessary.

Prior to your arrival, we request you alert us to any of the following:

- Any artificial joints or other metal medical implants that might alarm check-point metal detectors.
- Any nuclear medicine treatments that involved the ingestion or injection of radioactive material in the previous 30 days.
- If you have a pacemaker, mobility impairment, or other special need.
