Clean Water State Revolving Fund

...low interest loans

- publicly or privately owned facilities are eligible
- eligible projects include:
 - pipe, storage, treatment systems
 - green infrastructure; land or right-of-way purchase
- Statewide Project Priority List adopted annually

Proposition 84 Grant Program

- Storm Water
 - \$82M total - \$5M cap per project
 - local public agencies
- Areas of Special Biological Significance (ASBS)
 - \$32 M total - \$2.5M max amount
 - public agencies with application for exception to discharge prohibition

Proposition 84 Grant Program continued....

- **Storm Water Project Types**
 - Comply w/ storm water TMDLs
 - Low Impact Development
 - treatment/source control for new development
 - treat/recycle storm water
 - improvements to combined systems
 - required by NPDES storm water permits
 - assess project effectiveness

Proposition 84 Grant Program continued....

- **ASBS Funding Priorities....**
- **.... & some Preferences**
 - LID, smart growth, transit-oriented, green building
 - local agency commitment via policy or ordinance
 - Projects that support local land use planning for sustainable development
 - storm water treatment for re-use

Proposition 84 Grant Program continued....

- Storm Water
 - draft guidelines Fall 2008
 - applications late 2008
- ASBS
 - concept proposals due May 22, 2008
 - full proposals due September 10, 2008

SF Bay Water Board staff priorities for storm water grants and loans

- Low Impact Development projects
- Projects that retrofit existing storm water conveyances or other infrastructure
- Effectiveness monitoring & data management
- Projects that support local land use planning for sustainable development
