

### **Coastal Cleanup Drawing Rules**

In order to be eligible to enter the Coastal Cleanup Drawing, entrants:

1. Must have participated in Coastal Cleanup Day 2011;
2. Must be 13 years or over;
3. Must be a U.S. citizen.

Any contest entrant who does not meet all of the criteria listed above will be deemed ineligible to obtain a prize in the Coastal Cleanup Drawing.

The Coastal Cleanup Drawing is also subject to the following rules:

1. Only one prize may be awarded per household.
2. No purchase necessary to enter or win.
3. The contest is void where prohibited.
4. In case of a dispute as to the identity of an entrant using the Internet, the authorized account holder of the email address used to enter the Coastal Cleanup Day Drawing at the time of entry will be considered the entrant.
5. Sponsors are not responsible for any problems with your entry, including technical failures related to computer, telephone, cable, and unavailable network or server connections, or other failures related to hardware, software or virus, or incomplete, late or misdirected entries.
6. Acceptance of a prize constitutes the winner's consent to publicize his or her name and city in connection with the Coastal Cleanup Day Drawing.
7. Sponsor reserves the right to disqualify any person tampering with the operation or conduct of the Coastal Cleanup Day Drawing, including, without limitation, the entry process or the operation of the web site or otherwise violating these rules.
8. Sponsor reserves the right to cancel, terminate or modify the Coastal Cleanup Day Drawing if it cannot be operated, conducted or completed as planned, for any reason.
9. Prizes listed may be substituted for other first prizes of equal value, based on availability.

### **Coastal Cleanup Drawing Privacy Policy**

Personal information provided in conjunction with entering the Coastal Cleanup Day drawing ("Personal Information") will be collected solely for the purpose of selecting winners of the Coastal Cleanup Day drawing and for periodic communication about upcoming events, if the entrant opts to receive such emails. An entrant may request at any time that his or her Personal Information be discarded without reuse or distribution by contacting [coast4u@coastal.ca.gov](mailto:coast4u@coastal.ca.gov).

The Coastal Commission will delete all records of any Personal Information collected within 14 days of the end of the Coastal Cleanup Day drawing unless the entrant opts to receive further communications.

The California Coastal Commission will not sell or disclose Personal Information to any third parties.

Personal Information collected by the California Coastal Commission is exempt from the provisions of the Public Records Act (Chapter 3.5 (commencing with section 6250) of Division 7 of Title 1). Any

Personal Information acquired by the California Coastal Commission is subject to the limitations set forth in the Information Practices Act of 1977 (Title 1.8 (commencing with Section 1798) of Part 4 of Division 3 of the Civil Code).
